Sponsorship Options

The Walsh Family Law Moot was the first provincial family law moot in Canada started in 2013. This annual event is held at Osgoode Hall, Toronto. Law schools participating include University of Toronto, Osgoode Hall (York University), Queen's University, University of Windsor, University of Western Ontario, University of Ottawa and University of Manitoba. This is an exciting collaborative opportunity between law schools, legal academics, family justice system partners and AFCC-O. The goal is to offer law students an opportunity to gain experience and apply their knowledge to the practice of family law in Ontario.

In 2015, the first Walsh Family Law Negotiation Moot joined the Walsh Family Law Appellate Moot, focusing on the settlement discussions and negotiations take that place in family law cases.
