The Walsh Family Law Moot started in 2013. In 2015, the Walsh Family Law Negotiation Competition (focusing on the settlement discussions and negotiations that take place in family law cases) was created. In 2016 the two events were joined under the umbrella of the AFCC-O. The two are now one; running concurrently on the same day and involving many and varied dedicated professionals donating their time to assist in various capacities for the benefit of the students. This is an exciting collaborative opportunity between law schools, legal academics, family justice system partners and AFCC-O. The goal is to offer law students from all seven of Ontario's law schools an opportunity to gain experience and apply their knowledge to the practice of family law in Ontario.
